



# **Privacy Notice**

#### Introduction

In this Policy, where we refer to "**Greening**" (or "we"/"us"/"our"), we mean Greening Society Holdings Limited acting via its agent Monoceros Innovation Advisory Limited "**Monoceros**".

Greening is a company developing net zero solutions in the Island of Jersey. Greening is registered as a data controller with the Jersey Office of the Information Commissioner under number 100121.

Monoceros is an innovation consultancy operating in the Island of Jersey and manages the operations of Greening (an indirect subsidiary) on a day-to-day basis. Monoceros is registered as a data controller with the Jersey Office of the Information Commissioner under number 70446.

We may collect information from you through your use of this website, when you request information from us in respect of the Greening or engage with Greening products and services, or as a result of your relationship with us in the course of our business in each case in connection with the Greening.

References in this notice to "**your information**" are also to personal information that you provide to us or which we otherwise gather in the course of operating our business.

## The data we collect

We may collect various types of personal data about you, including:

- your personal identification information (which may include your name, your IP address and, personal data available in the public domain and such other information as may be necessary for Greening to provide its services or for Monoceros to provide its services to and in connection with Greening and to complete its CDD process and discharge its AML/CFT obligations)
- your contact information (which may include postal address and e-mail address and your home and mobile telephone numbers)
- your family relationships (which may include your marital status, the identity of your spouse and the number of children that you have)
- your professional and employment information (which may include your level of education and professional qualifications, your employment, employer's name and details of directorships and other offices which you may hold)

We may also review publically available information about you on your social media accounts.





# Where we obtain your personal data

We collect your personal information from the following sources:

- personal information which you give to us, such as:
- such other forms and documents as we may request that are completed in relation to the administration/management and operations of Greening and in connection with the Greening.
- information gathered through client due diligence carried out
- as part of our compliance with regulatory requirements (if applicable): any personal information provided by way of correspondence with us by phone, e-mail or otherwise
- personal information we receive from third party sources, such as:
  - our clients: in connection with matters upon which we are or may be instructed in connection with the Greening Society (for example where you are a counterparty to a transaction)
  - entities in which you or someone connected to you has an interest
  - your legal and/or other advisors
  - personal information received in the course of dealing with advisors, regulators, official authorities and service providers by whom you are employed or engaged or for whom you act.

# How we use your information

We are committed to protecting and respecting your privacy. Monoceros provide services to Greening and both Monoceros and Greening use your personal data for those purposes. Normally the purposes for which we use your personal data will be clear when we collect that data.

We will not use your personal data for purposes that are not clear when we collect that data and will only use your personal information to:

- conduct administrative or operational processes within our business;
- provide and improve our services to and in connection with Greening;
- compile anonymous statistics, for example website usage statistics;
- perform a contract which we or any member of the Greening group may have with you;
- comply with our legal and regulatory obligations;
- to establish, exercise or defend the legal rights of Monoceros or any Greening group company for the purpose of legal proceedings;
- process and respond to requests, enquiries or complaints received from you or someone connected to you;
- send you marketing material (e.g. papers and links to podcasts);
- provide you with personalised content;
- invite you to events;
- for other legitimate business purposes.

## How and why we share your information

We may share your personal information outside Monoceros and the Greening Society group. This may include disclosures to:

- third party agents, suppliers or contractors, in connection with the processing of your personal information for the purposes described in this policy, which may include, but is not limited to:
  - IT, software developers, website, marketing and communications service providers
  - our own advisers such as legal advisors, consultants, auditors and accountants which we may instruct from time to time
- third parties relevant to the services that we provide, which may include, but is not limited to:
  - counterparties to transactions
  - other professional service providers
  - regulators
  - law enforcement agencies
  - governmental institutions
  - courts





- to the extent required by law, regulation or court order, for example if we are under a duty to disclose your personal information in order to comply with any legal obligation such as our AML/CFT obligations
- we may disclose your personal information for the purposes of seeking references and confirmation of the details which you have provided should you apply for a position with us.

#### Direct marketing

We may ask whether you wish to receive marketing from us and this will be presented to you as an option on the relevant application form or page on our website where necessary. We may also contact you by email or other means to inform you about other services or events which may be of interest to you. You have the right at any time to stop us from contacting you for marketing purposes. If you wish to do so, please either unsubscribe or contact info@monocerosinnovation.com

## Retention of personal information and security

Your personal information will be retained for as long as required:

- for the purposes for which the personal information was collected
- to establish or defend legal rights or obligations or to satisfy any reporting or accounting obligations
- as required by data protection laws and any other applicable laws or regulatory requirements.

We will ensure that the personal information that we hold is subject to appropriate security measures.

## Access to and control of your personal information

You have the following rights in respect of the personal information about you that we process:

- the right to access and port personal information
- the right to rectify personal information
- the right to restrict the use of personal information
- the right to request that personal information is erased
- the right to object to processing of personal information.

You also have the right to lodge a complaint about the processing of your personal information either with us, with the Office of the Information Commissioner in Jersey (https://oicjersey.org).

Where we have relied on consent to process your personal information, you have the right to withdraw consent at any time.
